Home Credit Group B.V. ("**HC Group**") refers to its announcement of 15 July 2019. HC Group announces that its 100% subsidiary Home Credit N.V., formerly Home Credit B.V. ("**HCNV**"), has today submitted the Post Hearing Information Pack ("**PHIP**") to The Stock Exchange of Hong Kong Limited ("**HKSE**") with respect to a contemplated global offering of HCNV shares. The PHIP was submitted to the HKSE for publication on the website of the HKSE (www.hkexnews.hk). The PHIP contains, among other things, certain business and financial information relating to HCNV. The PHIP is in draft form and the information contained therein is subject to change which may be material. HC Group does not have any obligation or liability whatsoever in relation to the contents of the PHIP.

The HKSE listing and the contemplated global offering are subject to, among other things, the approval of the HKSE, the final decisions of corporate bodies of HC Group and HCNV, market conditions and other factors. Accordingly, there is no assurance that the listing or any global offering of HCNV shares will take place or as to when it may take place.

HCNV is the Netherlands-based holding company for Home Credit's operations in (i) South & South East Asia including India, Indonesia, Vietnam and Philippines; (ii) China; (iii) the Commonwealth of Independent States including Russia and Kazakhstan; and (iv) Central & Eastern Europe including the Czech Republic and Slovakia.
