



# Statement of NET4GAS regarding its second arbitration proceedings

**Prague, 17 June 2025**

In its release dated 4 January 2023, NET4GAS, s.r.o. ("**N4G**") announced that it had not received the latest monthly payments due under its material contracts with its major Russian shipper, Gazprom export ("**GPE**"). In its release dated 6 April 2023, N4G further announced that it had decided to initiate arbitration proceedings against GPE in order to protect its rights and seek the due payment of the amounts owed to it by GPE. In its release dated 6 March 2024, N4G announced that GPE is engaged in proceedings against N4G at a commercial court in Russia. N4G in its release dated 12 September 2024 further announced that it received the Arbitration Award issued in the first of the above-mentioned sets of arbitration proceedings, in which the Arbitration Tribunal accepted the argumentation of N4G and ruled fully in its favor.

N4G now announces that it has received the Arbitration Award issued in the second of the arbitration proceedings. In this Arbitration Award, the Arbitration Tribunal accepted the argumentation of N4G and ruled fully in its favor against GPE and its parent company.

N4G will now consider its further course of action as regards the possible enforcement of its claim.
